

FINAL REMINDER: Ova and Parasites (O&P)

Test Order/Collection Vial Change

PLEASE REVIEW AND TAKE ACTION AS APPROPRIATE TO AVOID SPECIMEN REJECTIONS

Effective NOVEMBER 7, 2023: SPECIMENS FOR O&P EXAM RECEIVED IN THE TOTAL-FIX™ VIAL WILL BE REJECTED

Background: On September 26, 2023, Pacific Diagnostic Laboratories (PDL) changed the test code and collection container for Ova and Parasite (O&P) Examination. We have allowed a transition period to avoid specimen rejections due to the collection vial change.

Effective November 7, 2023: We will be completely discontinuing the LAB955 OVA AND PARASITE (O&P) EXAMINATION test option. Any specimens received for O&P Exam in Total-Fix™ up to the November 7, 2023 date will be tested.

DEACTIVATE CODE - DISCONTINUE TOTAL-FIX™ VIAL

LAB955 / OVAF OVA AND PARASITE (O&P) EXAMINATION



Key Points:

- → Total-Fix™ specimens are NOT acceptable for the new O&P test and will be rejected.
- Collection Requirement update for Cryptosporidium/Giardia EIA
 Culture & Sensitivity (orange lid) vial is now acceptable for this test.
 - To simplify stool collection vials, PDL will be working to discontinue Total-Fix™ over the next few months.
 - If your office as remaining vials, Total-Fix™ can still be used for Cryptosporidium/Giardia EIA collections or vials can be returned to PDL.
- Consider Alternative Testing before ordering an O&P Exam
 American Society for Clinical Laboratory Science (ASCLS) provides the following guidance.
 - Do not order a comprehensive stool ova and parasite (O&P) microscopic exam on patients presenting with 1) diarrhea less than seven days' duration, 2) no immunodeficiency, 3) no history of living in or traveling to endemic areas where gastrointestinal parasitic infections are prevalent.
 - If symptoms of infectious diarrhea persist for seven days or longer, start with antigen testing.
 LAB10100 CRYPTOSPORIDIUM/GIARDIA by EIA Collection Vial: Culture & Sensitivity (orange lid)
 - Consider a full O&P microscopic exam if other testing is negative.
