NEW TEST ORDER FOR COVID-19

Effective February 2, 2021, Pacific Diagnostic Laboratories (PDL) is pleased to share we are now testing all molecular diagnostic COVID-19 from nasal and nasopharyngeal sources in-house. This change requires use of a new order code for SARS-CoV-2 (COVID-19) as noted below.

Courier Pickup: Specimen pick-up/transport to PDL through the standard courier process

- Please DO NOT drop off COVID-19 specimens or send suspected COVID-19 patients to a Patient Service Center
- PDL does not offer any collection services for this testing at the Patient Services Centers

METHODS IN USE

Hologic Panther Aptima® SARS CoV-2 assay combines the technologies of target capture, Transcription Mediated Amplification (TMA), and Dual Kinetic Assay (DKA).

LumiraDx SARS-CoV-2 RNA STAR is a molecular test kit, which uses a non-isothermal nucleic acid amplification technique called qSTAR (quantitative Selective Temperature Amplification Reaction).

COLLECTION

Nasopharyngeal (NP) collection: Must be performed by the physician or other healthcare provider following standard procedure and safety precautions.

Nasal collections: May be done by a physician or other healthcare provider. Observed self-collections are also acceptable following CDC guidelines.

PDL COVID-19 COLLECTION SITES are available by appointment only for symptomatic patients at Goleta and Santa Ynez. A test order must be placed AND patient must schedule an appointment by going online at www.pdllabs.com or calling 805-879-8100 or toll-free at 866-591-4610.
